The Chief Executive reported that Notice of the AGM had been given to all members of the PFA on 20 October 2009, more than 21 days before the AGM. Such notice was necessary due to a number of Special Resolutions being on the Agenda. The AGM Meeting Materials were also published on 23 October 2009, 21 days before the AGM, on www.pfa.net.au and referred to in the AGM Notice.

#### 3. ORDINARY BUSINESS

#### (a) Minutes of the 2008 Annual General Meeting

<u>IT WAS RESOLVED THAT</u> the minutes of the 2008 Annual General Meeting of the PFA which was held on 5 September 2008 be accepted as a true and accurate record of that meeting.

#### (b) Report from the Executive

The President referred to the *The Marston – 2009/2010 PFA Members' Guide* which had been distributed to all members detailing the activities of the PFA and Executive for the year ending 30 June 2009.

IT WAS RESOLVED that the Executive's report be accepted.

#### (c) Report from the Chief Executive

The Chief Executive referred to *The Marston – 2009/2010 PFA Members' Guide* which had been distributed to all members detailing the developments and the comprehensive work of the PFA in its various activity areas for the year ending 30 June 2009.

<u>IT WAS RESOLVED</u> that the Chief Executive's report be accepted.

#### (d) Declarations of Interest

The Chief Executive read out the declarations of interest set out at page 12 of the AGM Meeting Materials which had been published on www.pfa.net.au and referred to in the AGM Notice.

IT WAS RESOLVED that the declaration of interests be accepted.

#### (e) Election

The Chief Executive reported that, at a meeting of the PFA Executive held on 14 April 2009, Executive members Michael Valkanis and David Tarka tendered their resignations and that the Executive had, in accordance with Rule 10.5, respectively appointed Vincenzo Grella and Tim Cahill.

<u>IT WAS RESOLVED</u> to ratify the appointments of Vincenzo Grella and Tim Cahill to respectively replace the casual vacancies created by the resignation of Michael Valkanis and David Tarka.

The Chief Executive noted that, in accordance with Rule 10.5 of the Rules of the PFA, the term of appointment of Mr Cahill expired at the conclusion of the 2009 AGM and Mr Grella expired at the conclusion of the 2010 AGM.

The Chief Executive reported that Ante Milicic had resigned at an Executive meeting held immediately before the 2009 AGM and that the Executive had, in accordance with Rule 10.5 of the Rules of the PFA, appointed Chris Coyne to replace Mr Milicic.

IT WAS RESOLVED to ratify the appointment of Chris Coyne made 13 November 2009 to replace the casual vacancy created by the resignation of Ante Milicic.

The meeting warmly thanked Ante Milicic for his contribution and commitment to the Executive over several years.

Prior to the 2009 AGM and in accordance with Rule 24.4(c) of the Rules of the PFA, the Executive appointed Laura Sigal who is not an officer or employee of the PFA as the Returning Officer for the conduct of the election. The Returning Officer determined that the nominations were open from 26 October 2009 to 12.59pm on 13

November 2009 and gave notice in accordance with Rule 24.6 of the Rules of the PFA, to all Full Members, the Chairman, the President and the Chief Executive.

The Chief Executive further reported that the Returning Officer had received 5 written nominations for election as ordinary members of the Executive of the PFA in accordance with Rule 24.8 of the Rules of the PFA:

- Tim Cahill, nominated by Simon Colosimo (30 October 2009);
- Jon McKain, nominated by Michael Ferrante (29 October 2009);
- Liam Reddy, nominated by Matt McKay (22 October 2009);
- Kevin Muscat, nominated by Matt Kemp (5 November 2009); and
- Simon Colosimo, nominated by Alex Wilkinson (13 November 2009).

It was noted that the number of nominations equalled the number of vacancies.

<u>IT WAS DECLARED</u>, in accordance with Rule 24.10 of the Rules of the PFA, that Mr Cahill, Mr McKain, Mr Reddy, Mr Muscat and Mr Colosimo be deemed to be elected as ordinary members of the Executive of the PFA.

The meeting congratulated all elected, including new Executive member Chris Coyne.

### (f) Statements Required Under Section 30(3) of the *Associations Incorporation Act* 1981 (Vic)

The Chief Executive made a detailed presentation on the financial position of the PFA, noting the membership and work of the PFA Governance Committee, the PFA's 5 year financial objective, the PFA's financial performance against budget in 2008/2009 and the PFA's 4 year financial strategy including specific projections until 20010/2011.

In accordance with Section 30(3) of the <u>Associations Incorporation Act</u> 1981 (Vic), the following statements were also received. The statements were audited by the PFA's auditors, PKF, and were published on <u>www.pfa.net.au</u> on 23 October 2009, more than 14 days before the AGM:

- (i) statement of income and expenditure for the PFA for the 2008/2009 financial year; and
- (ii) particulars of assets and liabilities at the end of the 2008/2009 financial year.

The Chief Executive reported that in the view of the Executive:

- the statements give a true and fair view of the financial position of the PFA for the 2008/2009 financial year;
- there have been no subsequent events to alter that view; and
- there are reasonable grounds to believe the PFA will be able to pay its debts as and when they fall due.

IT WAS RESOLVED that the statements be accepted.

#### 4. SPECIAL BUSINESS

The special business transacted at the meeting was:

#### (a) Change of Name and Rules of the PFA

<u>IT WAS RESOLVED</u>, as a special resolution, that the name of association be changed from the Australian Professional Footballers' Association Inc to Professional Footballers Australia Inc and that the Rules of the PFA be changed accordingly.

#### (b) Alteration of the Rules of the PFA

<u>IT WAS RESOLVED</u>, as a special resolution, that the Rules of the PFA be altered as follows:

(i) amending Rule 17.12 to read:

Each member present at a meeting of a Delegates' Committee (including the person presiding at the meeting) is entitled to one vote and, in the event of an equality of votes on any question, the person presiding may exercise a second or casting vote. All votes must be given personally or by proxy given to a Member of the Delegate's Club or National Team approved by the Chief Executive.

(ii) all references in the Rules of the PFA to the Workplace Relations Act 1996 (Cth) be replaced with references to the Fair Work Act 2009 (Cth).

#### (c) Admission of Life Members

IT WAS RESOLVED, as a special resolution, that in accordance with Rules 5.1 and 5.2 of the Rules of the PFA, Ross Aloisi, Simon Colosimo, Ante Milicic and David Zdrilic be admitted as Life Members of the PFA.

#### (d) PFA Champion

<u>IT WAS RESOLVED</u>, as a special resolution, that in accordance with Rules 5.4 and 5.5 of the Rules of the PFA, PFA Life Member Craig Foster become a PFA Champion.

#### (e) General Business

#### (i) Collective Bargaining Strategy

The Chief Executive led a lengthy discussion regarding the current status of the Collective Bargaining Agreement (CBA) negotiations. In particular, round 2 (2009) - 4 key negotiations and round 3 (2013/2014) - establishing a revenue sharing model - of the PFA's Collective Bargaining Strategy were discussed.

#### (ii) PFA Player Management Agency

PFA Licensed Player Agent, Brad Maloney led a discussion regarding the PFA Player Management Agency, which would be officially launched in the coming weeks. In particular, the research conducted by PFA in respect of the quality of player agency services available to Australian players and what players wanted in a player agency was discussed.

#### (iii) Player Health and Safety

The Chief Executive led a discussion on Player Health and Safety. In particular, the prescribed minimum medical standards, PFA heat monitoring, injury reports and pitch rating system were discussed.

#### (d) Quorum

It was noted that, as the PFA has 408 Full Members, the quorum for the meeting is 41 Full Members (10%) provided 10 Full Members are personally in attendance (Rule 22.3 of the Rules of the PFA).

There being 145 Full Members in attendance (18 personally, 127 by proxy), a quorum was achieved.

### 3. REGISTRATION OF THE PFA UNDER THE FAIR WORK (REGISTERED ORGANISATIONS) ACT 2009 (CTH)

The Chief Executive spoke to the Explanatory Memorandum which accompanied the notice of meeting and made a PowerPoint presentation on the possible registration of the PFA under the *Fair Work (Registered Organisations) Act* 2009 (Cth) (**RO Act**).

The Chief Executive explained that, in the view of the PFA Executive, there are a number of major benefits should the PFA become a registered organisation of employees under the RO Act, especially regarding the PFA's capacity to bargain for and effectively represent its members who play in the A-League and with Australian national teams. However, the PFA has received advice that, to achieve registration under the RO Act, it may not be possible for the PFA to fully represent or have as members some or all of the following membership categories:

- Academy players;
- overseas based players not employed or seeking to be employed with a national team; and
- former players.

It was agreed that the PFA must continue to represent these membership categories.

It was agreed that the possible registration of the PFA would particularly further the objectives of the PFA by enabling the PFA to collectively bargain as a registered organisation under the *Fair Work Act* 2009 (Cth) on behalf of A-League and national team players. These players are also entitled to belong to the PFA if it is registered under the RO Act.

The Chief Executive referred to the power of the PFA under Rule 2(o) of the Rules of the PFA to establish legal entities for the furtherance of the Statement of Purposes of the PFA which include the advancement of the employment, industrial and career interests of professional footballers including A-League and national team players. Accordingly, the PFA could establish an association of employees for A-League and national team players which would, upon being registered under the RO Act, become a legal entity. The Chief Executive presented a summary of the structure of such an association and tabled Rules for that association.

It was agreed that it would further the objectives of the PFA to establish an association to become registered under the RO Act for these purposes.

It was resolved that the PFA Congress approves of the PFA Executive exercising its powers under Rule 11.1(a) of the Rules of the PFA to:

- (a) establish an association of employees for A-League and national team players (including players seeking to be employed as national team players) ("the Association");
- (b) authorise and licence the Association to adopt and use the name "Professional Footballers Australia" and the logo and trade mark of the PFA;
- (c) adopt the tabled Rules as the Rules of the Association;
- (d) appoint the current Officers of the PFA as the inaugural Officers of the Association:
- (e) provide for current members of the PFA who are eligible to be members of the Association to become members of the Association;
- (f) provide that, on an ongoing basis, members of the PFA who are also eligible to be members of the Association are members of both bodies;
- (g) approve the Association applying to become a registered organisation of employees under the RO Act; and
- (h) authorise the President and Chief Executive of the Association to make the requisite application.

Each Full Member in attendance, being an employee of an A-League club or Football Federation Australia in respect to the Socceroos, then indicated his agreement to become a member of the Association in accordance with the resolution.

### 4. SPECIAL RESOLUTION: ALTERATION OF THE STATEMENT OF PURPOSES AND THE RULES OF PROFESSIONAL FOOTBALLERS ASSOCIATION INC

It was noted that, in light of the resolution carried under Agenda Item 3, it was not appropriate to carry in its entirety the special resolution proposed in the material accompanying the notice of the meeting. However, it was noted that it was necessary or desirable to alter the Statement of Purposes and the Rules of the PFA in some respects:

- · to alter the Statement of Purposes;
- to alter the Rules of the PFA in relation to the terms of office holders; and
- to alter the Rules of the PFA in a number of general respects.

The Chief Executive tabled the Rules of the PFA with the recommended alterations highlighted and explained the proposed alterations.

#### (a) Statement of Purposes

It was resolved, as a special resolution, that the Statement of Purposes set out at Rule 2 of the Rules of the PFA be altered:

- by adding new Rule 2(j) to read:
  - "...to assist Members in preparing for and successfully transitioning to a new career and livelihood after they have retired from playing Football professionally;"
- by adding new Rule 2(k) to read:
  - "...to promote the personal development of Members including through community and charitable initiatives and programs;"
- by renumbering Rules 2(j), (k), (l), and (m) as Rules 2(l), (m), (n) and (o) respectively;
- by deleting "and" at the end of Rule 2(n); and
- by adding new Rule 2(p) to read:

"to cause to have established funds for the furtherance of these objectives and to assist with the administration of such funds; and..."

#### (b) Alteration of Rules - Term of Office

It was resolved, as a special resolution, that the Rules of the PFA be altered:

- by deleting "4 Years" in Rule 24.2(b) and inserting "2 Years" (maximum term of office of the Chairman);
- by deleting "one Year" in Rule 24.2(c) and inserting "2 Years" (term of office of the President);
- by deleting "each Year" in Rule 24.3 and inserting "every second Year" (frequency of elections);
- by adding new Rule 24.3A to read:

"For transitional purposes and subject to these Rules, the term or terms of office of:

- (a) John Poulakakis as Chairman expires on 30 November 2010;
- (b) Simon Colosimo as President expires on 30 November 2010;
- (c) Brendan Schwab as Chief Executive expires on 31 March 2013;
- (d) John Aloisi, Ante Covic, Chris Coyne, Vincenzo Grella and Alex Wilkinson as ordinary members of the PFA Executive expire on 30 November 2010; and
- (e) Tim Cahill, Simon Colosimo, Jon McKain, Kevin Muscat and Liam Reddy as ordinary members of the PFA Executive expire on 30 November 2012."; and
- by adding new Rule 24.3B to read:

"Where a term of office is to expire under Rule 24.3A on 30 November in a Year and the PFA Executive has determined under Rule 24.4(a) to hold the election for the office at the Annual General Meeting in that Year, the term of office instead expires on the conclusion of that Annual General Meeting."

#### (c) Alteration of Rules - General

The Manager, Player Relations, led a detailed discussion over pressing issues facing PFA Members at present, including key PFA negotiations in 2009/10, important cases handled by the PFA, security for A-League player payments, the proposed tightening of player transfer regulations, funding for player programs and the relationship between these issues and the A-League salary cap.

#### (b) 2010 A-League Player Survey

The Manager, Player Services & Community, reported that the players' concerns over pressing issues had been reflected in the results of the 2010 survey of A-League players conducted by the PFA.

#### (c) Collective Bargaining Priorities

It was agreed that the PFA's priorities for the 2010 collective bargaining negotiations are to address the pressing issues and prepare the framework for players to receive a fair share of game revenue as the game grows in the next round of broadcast rights negotiations.

#### (d) Negotiations Approach and Strategy

It was agreed that the PFA work to reach agreement for both national team and A-League players by 30 September 2010, as this coincides with the expiry of the current Socceroos Collective Bargaining Agreement and the scheduled review of the A-League CBA. It has been a long-standing policy of the PFA to achieve a "whole of game" CBA for all member groups.

#### 6. GENERAL BUSINESS

There was no general business.

The agreement is for an open ended duration terminable on the giving of one month's notice by either party.

#### 5.4 Chief Executive Brendan Schwab

Chief Executive Brendan Schwab is employed by the PFA in a full-time capacity under a contract of employment approved by the PFA Executive on terms recommended by the PFA Governance Committee in July 2008. The agreement, for a term of 3 years to expire on 31 March 2011, was extended to 31 March 2013 on the approval of the PFA Executive in November 2009.

#### 5.5 Statement of Compliance

Apart from the matters declared above, no member of the Executive receives any remuneration or other benefit in consideration of or in connection with his membership of the Executive, other than the payment or reimbursement of expenses directly incurred in attending Executive meetings.
