The next 12 months represent a unique opportunity for Australian football. The Socceroos have qualified for a fifth consecutive FIFA Men's World Cup. The FIFA Women's World Cup arrives on our shores next July. And our A-Leagues can hit the rebuild button after three arduous campaigns affected by COVID-19.

Without anticipating the future, the next
A-League Men campaign will hopefully be the
first full season without major disruption caused
by the pandemic. If anything, the last three
seasons have proven that our domestic competitions – and its players, staff, and administrators
– are incredibly resilient. After riding a tsunami
of uncertainty, the A-League Men and Women
survived.

Ensuring the survival of the professional game has required immense sacrifice from players, coaches and staff, with this generation being owed a debt that can only be adequately repaid by ensuring that the professional game transitions from surviving to thriving.

While regular discussion in our game and critique of the A-League Men competition has focused on what Australian football doesn't possess in comparison to other football markets, the core findings outlined in this Report, which uses data analysis, evidence, and player feedback to build a picture of the top tier of Australian football, paints a positive picture.

The findings include:

 the A-League Men leads all other Asian competitions for providing opportunities for young talent;

- the competition is the most competitively balanced league in Asia;
- investment into player payments has returned to pre-pandemic levels; and
- player churn continues to trend downwards following the establishment of a five-year collective bargaining agreement (CBA).

Equally, the Report signposts the areas we need to address. The emergence of players such as Kye Rowles, Jordan Bos, Bernardo Oliveira, Kusini Yengi and Nestory Irankunda highlight that our collective challenge is to now turn opportunity into sustained development of these players on and off the pitch.

In addition, despite the clear impact of the CBA, a minority of clubs continue to operate as if the rules do not apply to them. The feedback from some players and their club's ladder position reflects that non-compliance acts only as a means of self-sabotage for them and the professional game in this country. The opportunities of the next 12 months will not be realised if the practices of the few continue to distract the majority from the positive and productive work that is required.

Finally, the past three seasons have required immense courage and it is truly an honour to work on behalf of players so committed to both the profession and the game. This courage has been sustained through a belief in what our game can and should be and the PFA remains committed to helping our game transition from not just surviving, but to thriving.

PFA A-League Men Report 2021/22

For players, understanding the game of football and the industry within which they are employed is critical to building meaningful lives and careers – in Australia and abroad. Equally important is the regular assessment and benchmarking – through player feedback and analysis – of our domestic competitions to ensure Australian football is progressing against its objectives and meeting the game's collective ambition of international competitiveness and success.

Since 2016, the PFA has conducted research of Australia's domestic competitions – now known as A-League Women and A-League Men – and gathered anecdotal feedback from its members for the dual purpose of supporting our players and shaping a better professional game.

Across the past six Reports charting the evolution of the A-League Men's competition, the PFA has focused on four key areas of analysis and assessment, exploring the players' employment framework, conducting a league assessment and composing a technical report before finally exploring the level of player development on and off the pitch.

To build this report, several sources of data were utilised: the PFA's A-League Men end of season survey, statistical data sourced from InStat, research sourced from the CIES Football Observatory and FIFA, and research conducted in partnership between the PFA and Twenty First Group.

#### A-LEAGUE MEN SURVEY

Every A-League Men player was sent a link to a PFA online survey at the conclusion of the 2021/22 season. Between June and July, 170 players responded to the survey.

The survey covered a broad range of areas impacting their career, from contract status, to work and study outside of football, transition-readiness, assessments of their club, the A-League Men competition, collective bargaining, player development and the performance of their union, the PFA.

#### CIES FOOTBALL OBERSVATORY

The CIES Football Observatory is a research group created in 2005 within the Swiss-based Centre International d'Étude du Sport (CIES). It specialises in the statistical analysis of football, in particular in the areas of demographics, transfer values and performance.



The 2021/22 season was the third consecutive A-League Men campaign severely impacted by COVID-19. Despite the expectation of a new season under the Australian Professional Leagues (APL) administration, a freshly inked five-year Collective Bargaining Agreement (CBA) and a five-year broadcast agreement, the Omicron variant of COVID-19 caused interruption by week five of the campaign.

That disruption resulted in the rescheduling of over 50% of matches, or 80 of the 156 A-League Men's regular season fixtures. Players and staff regularly tested positive to the virus and state border closures caused havoc with team travel.

Given the global nature of COVID-19, elite and grassroots sport world-wide have continued to experience the ongoing impact of the pandemic since early 2020. According to Deloitte's Annual Review of Football Finance published in 2021, the European football market contracted by 13% in 2019/20: the first reduction in the market since the global financial crisis in 2008/09. In Australia, the AFL - the biggest football code in the country - reported losses of \$43 million, with its clubs spending an additional \$76 million in the past two years due to the pandemic.

The impact on clubs, the players and the A-League Men has been perhaps more devastating. While the European football market has already rallied and the AFL largely avoided the impacts of Omicron in the early stages of its 2022 season, the 2021/22 A-League Men season was heavily impacted.

While most of the focus was on the storylines that accompanied COVID-19's impact, the A-League Men competition again demonstrated its resilience in the face of disruption. An increased number of scholarship players available on club rosters resulted in an increase in the number of Australian players receiving match minutes at the top level.

Total player payments have recovered to near pre-pandemic levels, the A-League Men remains the most competitively balanced league in Asia, the average age continues to hover around 25 and opportunities for young Australian players receiving match minutes at the top level continues to increase.

#### **Player Payments**

Salary cap to increase from \$2.5m to \$2.6m between 2021 – 2023. Two new categorised 'Designated Players' to have salaries (between \$300,000 to \$600,000) outside of salary cap, in addition to two marquees whose salaries are outside the salary cap (no limit to salary)



#### Player Insurance Scheme

78 weeks of income protection coverage and career ending insurance capped at \$500,000



#### Enhanced Minimum Workplace and Performance Standards

Clubs are required to meet the minimum workplace and performance standards



#### Guaranteed Player Development Funding

Commencing at \$700,000, and increasing over the first three seasons to \$800.000




#### **Review Trigger**

To ensure players continue to receive a fair share of the game's revenues, the CBA includes a Review Trigger. If agreed revenue benchmarks are met, the PFA will then have the right to renegotiate the following matters:

- · the minimum wage
- salary cap (both maximum and minimum)
- · player payments
- prize money allocation to players
- · Player Development Program funding







Since the pandemic has impacted Australian football, the average age of players in the A-League Men has dropped significantly. Players aged 23 or under represented 45% of all contracted players during the 2021/22 season. Consequently, the average age is 25.

Through the CBA signed last September, the A-League Men clubs and the PFA agreed to extend the number of scholarship contracts from nine to 16, which is likely to have contributed to the average drop in age, as well

as providing opportunity for younger players.


In fact, the A-League Men leads all other leagues in the Asian Football Confederation (AFC) for providing opportunities for its emerging talent, according to a 2022 report released by the Football Observatory, a research group which specialises in the statistical analysis of football.

In another CIES Report released in May this year, the Mariners' Jacob Farrell (52nd) and Sydney FC's Patrick Yazbek (67th) were listed in the top 100 footballers under the age of 20 who gained the most playing experience during the first semester of the year, joining a list of players including the likes of Jude Bellingham (1), Pablo Gavi (2) and Fabio Carvalho (7).




#### PERCENTAGE (%) OF MINUTES PLAYED BY U21 PLAYERS (LEAGUES COMPARISON)





#### INTERNATIONAL TRANSFERS


A selection of players have departed the A-League Men for overseas clubs for international transfer fees in the past 12 months, with Scottish Premier League clubs a popular destination for Australian talent.

PFA analysis of Australian international transfer receipts for men's players since 2006 reveals the two most recent transfer windows (January 2022 and May-September 2022) represent the highest in transfer receipts in the past four years. Australian clubs have received over \$3m

in transfer receipts during the two most recent transfer windows.

The combination of young players receiving match minutes in the A-League Men and exposure for Australia's national teams is likely to have placed the likes of Lewis Miller (Hibernian), Kye Rowles (Heart of Midlothian), Connor Metcalfe (St Pauli), Joshua Rawlins (FC Utrecht), Mohamed Toure (Reims) and Yaya Dukuly (Reims) in the 'shop window' for European clubs.

Where does Australia sit within the International Transfer Market?

To gain a better understanding of where Australia sits within the global transfer market, the PFA examined the FIFA Ten Years of International Transfers Report – A Report on International Football Transfers Worldwide 2011-2020. While this Report excludes an analysis of the most recent windows (2021-22), and the broader cultural, social and economic analysis of global football markets, it provides a long-term overview of Australia's position within the global transfer market in terms of fees received and spending on transfers against 200 other countries. The following conclusions can be drawn from an analysis of the data:



Australia made US\$26.6m profit on the international transfer market between 2011-2020, receiving a total of US\$30.5m for outgoing transfers and spending US\$3.9m on incoming transfers;



This placed Australia in 38th position globally in terms of its net position (+\$26.6m), which is closely behind the likes of Nigeria (34th, +\$35m), Costa Rica (35th, +\$30.4m), Tunisia (36th, +\$30m) and Finland (37th +\$28m), but ahead of Bosnia & Herzegovina, Senegal, Montenegro, Cameroon, Belarus and Hungary;



Within the AFC, Australia ranks second in terms of its *net position from transfer* activity (+\$26m), behind only South Korea (+\$78m);

Australia's AFC rivals Japan (-\$37.7m), India (-\$37.7m), UAE (-\$259.3m), Qatar (-\$278.4m), Saudi Arabia (-\$481.2m) and China (-\$1.45bn) made combined losses of \$2.55bn;



In a comparison against profitable countries on the transfer market, Australia is ranked 38th, despite not spending or generating the significant sums many established football countries in Europe and South America do.


European clubs made the most transfers - both incoming and outgoing - as well as paying and receiving the largest amounts in transfer fees. Where transfer fees were concerned, European clubs' share was 87% of the total amount paid and 83% of the total fees received in the last ten years, indicating the international transfer market is dominated almost exclusively by clubs in UEFA competitions. Across the decade analysed by FIFA, US\$40.4bn in transfer fees were received by clubs in UEFA, versus US\$885.6m in the AFC region: just over 20% of the fees received in Europe. Of the US\$3.3bn spent on transfers in the AFC region, over half is accounted for by China's spending to bolster the Chinese Super League with talent: US\$1.69bn was spent by Chinese clubs between 2011-2020.

#### DOMESTIC MOVEMENT

Analysing the movement of players between A-League Men clubs and the tier below the A-League Men, the National Premier Leagues, indicates that most players move down from the A-League Men, the A-League Youth competition and A-League academies into the NPL. Only a small percentage across the analysed period (2016 – 2022) move from the NPL into the A-League Men, at an average of 8.16 per season.

The data regarding player movement indicates that A-League Men clubs are increasingly reliant on their own academies and/or youth teams to produce A-League Men players.

The professional game also supplies more players to the NPL competition than the inverse by a ratio of 9 to 1. This finding has important policy implications and pushes back against the notion that a fee paying Domestic Transfer System and revised training compensation framework are likely to result in significant revenue redistribution within Australian club football. The data indicates the professional game is better equipped to spot and develop talent than the lower tiers of the game or is at least more likely to focus on developing and promoting talent from within. Subsequently, significant revenue redistribution within the Australian football ecosystem is extremely unlikely.

In combining available data for the 2020/21 and 2021/22 seasons in relation to the movement of players into A-League Men competition from the NPL, the PFA developed the following player profile:

- Average Salary for player joining the A-League Men from the NPL: \$43,808.97
- Average contract length for player joining A-League Men from NPL: 1.59 seasons
- Average number of matches played in first A-league Men season from NPL: 11.8 matches
- Average number of match minutes in first A-League Men season from NPL: 556.05 minutes

What is clear from this profile is that the first move a player makes into the A-League Men competition is often the most fragile and volatile one, in terms of salary, contractual stability and playing opportunities. If that is the case with relatively low barriers to entry, then the likely implication of increasing the barriers is that the movement of players will become more difficult and create a self-defeating cycle that denies players access to the professional game.

#### In addition:

- 60% of the current NPL players across the country paid fees in excess of \$1,000 per year between the ages of 12 and 18; and
- 50% of NPL players are paid less than \$500 per week.


# **PLAYER CHURN**

The percentage of players coming off contract at the start of the 2021/22 season was the lowest in eight years (since the PFA has analysed player contract data). Given the negative impact of churn on players' careers and the impact to on-field performance via squad instability, this is a positive outcome for players, clubs, and the league.

While a variety of factors could be at play, the five-year CBA currently in place has provided clubs and players with a significant amount of certainty.







In research conducted by Twenty First Group in partnership with the PFA, the current contract length of Australian players in the A-League Men was found to be the among the highest in comparator leagues from Africa, South America, North America and Asia, and was the highest in the AFC region.

# The contracting practices of clubs have also changed dramatically since the pandemic and owing to the new level of certainty delivered by the long-term CBA. The number of players on one year deals has reduced – from 51% to 39% - and those on two-year deals have increased to 48%, providing more career certainty for players and more roster certainty for clubs.

#### CONTRACT LENGTH PERCENTAGE




## MATCH MINUTES

While 45% of contracted players were aged under 23 this campaign, 42% of match minutes were occupied by players under 25. Players aged between 26-30 played 34% of the total match minutes available, while there was a decline in the number of match minutes played by players over the age of 30 – with just 24% occupied by this cohort: the lowest percentage in past five seasons compared.





#### HOW WOULD YOU RATE THE PERFORMANCE STANDARDS AT YOUR CLUB?










POINTS SPREAD COMPARISON


**PFA A-League Men** Report 2021/22

Through research conducted by the PFA in partnership with Twenty First Group, the A-League is the most competitive among the top leagues in Asia across the past decade. Through its club quality benchmarking tool, Twenty First Group analysed the quality gap between clubs within the top AFC leagues.


The research delivered two important findings: that the ALM has the closest level of quality among its 12 teams and the ALM's competitiveness is demonstrated by the tightest points spread in Asia across the past 10 seasons analysed (2012-2022).



With A-League Men attendances in gradual decline prior to COVID-19 and suffering a significant decrease due to COVID-19 between 2020 – 2022, the APL will be seeking to entice fans and members back through the gates in increasing numbers when the 2022/23 season kicks off. With COVID-19 restrictions likely to be entirely lifted and a fixed schedule, there is an expectation that the competition will experience an uptick in attendances following three COVID-19 impacted campaigns.

But the question remains: what is an acceptable number of fans for the A-League Men to attract and aspire to in the short term as the league continues to rebuild post-pandemic? The A-League Men cannot hope to pack out stadia like Premier League or Bundesliga powerhouses can, nor go close to competing with the AFL for record spectators (before the pandemic, the AFL consistently ranked as the fourth highest attended league globally, behind America's National Football League (NFL), England's Premier League and Germany's Bundesliga).

For the A-League Men, respectable crowd figures are important. Revenue from ticketing and memberships provide clubs with a significant portion of their overall operating revenues, so it is imperative to deliver 'bums on seats'. Eyeballs on the league also helps to attract commercial partners in a crowded sporting marketplace. For the players a colourful atmosphere can lift and motivate the team, and for TV viewers, atmosphere excites fans beyond the action on the

pitch. For fans in the stadium, being part of passionate displays can enhance the match day experience.

Taking into account these factors, and to consider an achievable average attendance target for the 2022/23 campaign, the PFA has benchmarked the A-League Men against the average attendances of 14 AFC domestic leagues between 2010-2022. These attendances were then compared against research into average attendances in football stadia across 51 countries from Europe, North America and Asia, conducted by the CIES Football Observatory between 2013 – 2018.

Contrary to widely accepted opinion in Australia, the research demonstrates that the A-League Men, in comparison to both AFC and global football competitions, attracts respectable average attendances.

In the AFC region, Australia ranks fourth in average attendances (for the period recorded), behind the world's two most populous countries, India and China, and Japan and Indonesia, which have five- and ten-times Australia's population to draw their attendances from, respectively. In a per capita comparison, the A-League Men leads all other AFC competitions.


Measured against CIES Football Observatory research of global league attendances, Australia would rank 14th in the world when compared with 51 other football leagues globally, with an average attendance of over 11,875 during the period analysed (2013-2018) and above the 11,355 average across 51 comparison leagues.

When considering the population crowds are drawn from within Australia's competitive sporting marketplace, they suggest a healthy opportunity for the sport to build upon. What it also says is that Australian domestic club football does not need to compete with other sports to draw crowds that rate well against regional and global comparisons within our own sport. A target of 10,000 average spectators across the 2022/23 season would be a realistic platform for future growth, and elevate the A-League Men back within the top 20 best attended football leagues in the world.

The objective for A-League Men clubs and the Australian football community should be to cast aside erroneous comparisons with other sport attendances, ignore the attempts to stir up 'code wars' and instead refocus on creating an unrivalled atmosphere on match days which attracts people through the turnstiles not once, but for a lifetime. For some clubs, this is achievable now, particularly through their current fanbase, connection to community and unique stadia. Others face challenges when playing in unsuitable stadia and in building community connection, but with time, investment and commitment to a long-term strategy, the A-League Men can once again be ranked among the top leagues worldwide for average attendance.





## PLAYERS' SURVEY

For the first time in composing this Report, the PFA asked players in its annual survey to define the prevailing style of football in the A-League Men competition in three words. The results have been collated into the following visual word cloud, which indicates the descriptors utilised - with the most frequently used emphasised by their increasing size.


The most common phrases to describe the style of play were transition or transitional (37 mentions), physical (28), tactical (14) and fast (12). While those familiar with the A-League Men are likely to agree with those descriptors, the use of the following terms – entertaining, exciting, high tempo, intense, unpredictable, dynamic, erratic and inconsistent – indicates that the players view the A-League Men competition as one that provides a level of theatre, competitiveness and randomness. Those are ingredients which provide for a compelling on-field experience for the players and perhaps a developmental environment that challenges players.

While this is a limited analysis of the phrases used by the playing cohort (for example, the use of the term 'tactical' does not explore what tactics are deployed by teams), the limited use of the term possession (5 mentions) and passing (no mentions) indicates there is less focus on possession maintenance versus transition.




#### TO WHAT EXTENT DO YOU FEEL YOU DEVELOPED AS A PLAYER THIS SEASON?




WHAT WOULD BE THE MAIN FOCUS POINTS OF COACHING IN MATCH PREPERATION?

With the players defining the A-League Men competition as predominantly transitional and physical, the PFA conducted further analysis of the competition, exploring data around possession, playing styles, defensive output and shot creation across 12 clubs.

The A-League teams were compared against the performance and trends of clubs from four other competitions: North America's Major League Soccer, Japan's J-League, the Scottish Premiership and the Swedish Allesvenskan. Those four leagues were selected due to the following factors:


- MLS the league possesses similar labour market regulations, such as a salary cap
- J-League the top-ranked competition in the AFC
- Scottish Premiership given recent Australian player migration to the Scottish Premiership
- Swedish Allesvenskan the Allesvenskan is ranked 27th globally, two places ahead of the A-League Men (29th) (based on Football Rankings)


Save for exceptions in Adelaide United and the Newcastle Jets, the prevailing defensive approach across the A-League Men is driven by containment and therefore teams tend to avoid substantial pressing of their opponent.

POSSESSION VOLUME/TIME

This contributes to a lower volume and longer duration of possession per team, as evidenced in comparison to the other four leagues in the sample data. Six of the 12 A-League Men teams last season accumulated lower than the total average of 103.67 possessions per match, however, 10 averaged a possession duration longer than the average 15.59 seconds.

Where teams in the A-League Men differentiate are in the phases where shots are created, with one example being Adelaide generating a shot from 21.5% of transition attacks but only 9.2% percent of attacks against a set defence.






The league's prevalent possession style is ultimately a consequence of the defensive approach, where to defend means to contain instead of pressuring into mistakes.

It is not unnoticeable that in the sample data, Western United's average of 7.38 passes per defensive action ranks among the lowest in the five leagues compared, with Brisbane Roar (7.43) and Wellington Phoenix (7.4) the only two teams with higher volumes in that category. This is before considering game state and whether a team is having to protect or chase a result.

Along with Adelaide United and Newcastle Jets, Melbourne City are the only side in the A-League Men generally concerned with territory from a defensive standpoint, while the rest are willing to concede it, in the hope of both absorbing opposition phases of possession while potentially creating more space to attack in transition.

Melbourne City, Sydney FC, Adelaide United and Newcastle Jets attempt the most tackles per 90 minutes and only rank behind LA and New York Red Bull in the MLS.
