There were three (3) meetings of the Trustees, two held in conjunction with the Governance Committee and one in conjunction with the Governance and Executive Committee in the 2022/23 financial year; the first meeting was held on 4 October 2022, the second on 15 February 2023, and the third on 7 June 2023.

There was no change in the composition of the Trustees from the previous financial year. Gender balance remains of particular importance in keeping with the principles of best practice governance and the PFA's commitment to gender equality. The PFA Executive fully supports this position.
